A maximum of 5-6 keywords should be mentioned at the end of the abstract. The corresponding author should be highlighted and his/her email id should be mentioned. The word limit for the abstract should be up to 300 words.

POSTER: The Poster Size should be of 120 cm height and 90 cm width. Mention PMBJP Conference 2022, Department of Pharmaceutical Sciences, Bhimtal (UK). Poster can be submitted by researcher/students working in the field of: All branches of Pharmaceutical Sciences, Biotechnology, MBA (Marketing), Natural Product chemistry, Drug discovery and Life sciences.
